

Dear Shonda Tindall:

This letter grants your students permission to film on public property within the City of Long Beach within a one (1) mile radius of the Long Beach Convention Center on Thursday, March 14, 2024, through Saturday, March 16, 2024, between the hours of 7:00 AM and 10:00 PM ONLY. Insurance has been received and processed through the City of Long Beach Risk Management. Please refer to the attached map showing where students are NOT allowed to film. **Filming on the Port of Long Beach property, the Queen Mary, and/or private property are strictly prohibited.**

- Production MUST have permission from property owners in order to film on private property.
- Production MUST leave a 4-foot pedestrian access on sidewalks/walkways at all times.
- Production may NOT have camera, equipment, or persons in the street, bike/curb/parking lot through lanes, alleys, medians, and/or crosswalks at any time, NO EXCEPTIONS.
- Production MUST work within lights and crosswalks to cross the street.
- Production may NOT block ingress/egress to businesses/residences, red/blue curb, bus stops, alleys, and/or driveways/garages at any time, NO EXCEPTIONS.
- Production shall be mindful of noise levels at all times, NO EXCEPTIONS.
- Production shall NOT use profanity in public at any time, NO EXCEPTIONS.
- Production may NOT have lighting, equipment, and/or parking affect patrons/residences/businesses and/or traffic/bike/parking lot through lanes at any time, NO EXCEPTIONS.
- Production shall NOT have fake blood, weapons, use pyrotechnics, have talent dressed in uniform (i.e. PD, Fire, Military, etc.), display of violence, simulated drug use, and/or sexual content of any kind in view of the public at any time, NO EXCEPTIONS.
- Production may NOT have camera, equipment, and/or persons static/obstructing bike paths at any time, NO EXCEPTIONS. Talent must ride IN FLOW ONLY.
- Production/Talent may NOT be in the ocean/water at any time, NO EXCEPTIONS.
- Production shall NOT interfere with Grand Prix construction at any time, NO EXCEPTIONS.
- Production shall NOT interfere with any permitted filming/events at any time, NO EXCEPTIONS.

STUDENTS MUST LEAVE A 4-FOOT PEDESTRIAN ACCESS ON SIDEWALKS/WALKWAYS AT ALL TIMES.

STUDENTS MAY NOT HAVE CAMERA/EQUIPMENT ON AND/OR PERSONS BLOCKING THE BEACH BIKE PATH AT ANY TIME. STUDENTS MAY NOT BE IN THE WATER/OCEAN AT ANY TIME.

STUDENTS SHALL NOT INTERFERE WITH GRAND PRIX CONSTRUCTION AT ANY TIME.

NO FILMING AT THE QUEEN MARY, PORT OF LONG BEACH, OR PRIVATE PROPERTIES.
